Third Party Fundraising Guidelines & Agreement

Thank you for your interest in raising funds to support the Canadian Centre for Men and Families (CCMF). The CCMF is operated by the registered educational charity Canadian Association for Equality (Registered charity/business number 841583719RR0001).

CCMF is a game changer in response to the devastating trends in men's health, fatherlessness and the educational underperformance of boys. Our work helps to strengthen families and to make our communities healthier.

Every event, big or small, makes a huge difference to the men and boys we serve. Each year a number of special events raise funds that support our Centre's many programs. These events are hosted by both individuals and groups who want to contribute to the important work we do.

To allow CCMF to review and approve your proposed activity, we ask that you complete and submit this Agreement to the fundraising committee. Your application will be reviewed and a member will contact you with next steps.

1. During the term of your approved fundraising project we grant the organizing group the right to use our name and logo solely for the purpose of promoting the agreed upon event and for raising funds to benefit CCMF.
2. CCMF will not be responsible for any costs associated with the planning and/or execution of the event.
3. All necessary insurance coverage, licenses, and other legal requirements will be secured by the organizing group and will be at its own expense.
4. The organizing group agrees that it does not intend to, and will not, receive or accept payment or compensation for organizing or administering the event or for raising funds for CCMF.
5. CCMF cannot guarantee that volunteers, staff or board members will participate in administrative support, the planning and/or implementation of your project or event.
6. As a registered charitable organization, we must comply with all Canada Revenue Agency (CRA) rules and regulations. We reserve the right to audit all records pertaining to the organizing group's event to ensure compliance with the CRA and to maintain transparency with our donors and stakeholders.

The organizing group indemnifies and holds harmless the Canadian Centre for Men and Families and the Canadian Association for Equality, its directors, officers, employees, volunteers and stakeholders from and against all liability, actions, claims, losses, costs and damages which may be brought against or suffered by the organizing group in connection with the event/promotion.

The Canadian Association for Equality Board of Directors retains the right to revoke or terminate any authorization it may give for use of the CCMF name and logo.
